QUALIFICATION:

Master's Degree (equivalent to 18 years of Education) in Engineering (Electrical, Electronics, Computer, ICT related disciplines)/Computer Sciences/ICT/Management/Business Administration from HEC recognized local or foreign university

OR

Bachelor's Degree (equivalent to 16 years of Education) in Engineering (Electrical, Electronics, Computer, ICT related disciplines)/Computer Sciences/ICT/Management/Business Administration from HEC recognized local or foreign university.

EXPERIENCE:

Candidates with Master's Degree are required to have at least ten (10) years of experience including three years of senior management level positions within ICT Industry and related public sector organizations.

Candidates with Bachelor's Degree are required to have at least twelve (12) years of experience including three years of senior management level position within ICT Industry and related public sector organizations.

Candidate's professional credentials should include the following:

- a) Experience in developing, maintaining and improving cooperative relationship with international multilateral organizations and forums on ICTs.
- b) Thorough understanding of latest technologies for local and regional market situation, identifying competitive analysis attributes for the development of new economic opportunities through multilateral forums.
- c) Possess information and understanding of regional integration programs through ICTs.
- d) Effective communications skills.
- e) Proven event management experience to design and conduct high level events.

UPPER AGE LIMIT: 45 years



CONDITION TO APPLY:

- a) In case of selection candidates working in public/private Sector will have to sever off their previous posts/service before joining. NOC from present employer in case of Government Servants is mandatory alongwith application.
- b) Initial period of contract appointment is two years (extendable).
- c) The position offers salary package/benefits as admissible under the Government MP-III Scale package.
